3. Four (4) most recent pay stubs, pension letter, or social security award letter. If self-employed, verified letter from accountant and copy of Schedule C.
4. Tenant Leger from your management company (last 12 months) or if you live in a private house, last twelve months of canceled rent checks.
5. Government issued ID i.e. Driver's License or DMV IDcard.
